**EXPRESSION OF INTEREST (EOI) FOR PRODUCTION OF
RESOURCE MATERIAL FOR DIFFERENT MEDIA**

Govt. Of India has received loan from the World Bank (IBRD loan no. 4749-IN) for implementation of Hydrology Project (phase-II). It is proposed to create resource material which forms a part of the implementation of HP-11 activities under the **Component-1: Institutional strengthening, Sub component- IB: awareness raising, data dissemination and knowledge sharing.** The Senior Geologist, Remote sensing Division on behalf of the Chief Engineer and Director, Ground Water Survey & Investigation, Orissa intends to invite expression of interest (EOI) from the eligible Door Darshan Empanelled producers/production firms for creation of resource material for different media. Interested firms must have a) at least 10 years of past experience in creation of resource material, b) experience of working at least 12(twelve) episodes of commissioned programmes for Doordarshan c) should have valid service and PAN number.

The scope of work includes production of video documentary relating to awareness on ground water and activities of the Directorate of Ground Water Survey and Investigation, Orissa in water sector in DVC pro/DV CAM format of 27 minutes duration.

The interested firms in their EOI must provide the following information. A) Brief profile of the firm / producers indicating the biodata of the production team, B) List of the programmes successfully produced for different organisations preferably Door Darshan (with a show reel of the programme produced in a CD/DVD) C) Service Tax registration No. & PAN No., and D) Door Darshan Empanelment documents.

The format (hard copy) for submitting the EOI is available in the office of the undersigned, which can be collected by the intending firms. The soft copy of the format will also be made available to the intending firms (will be sent in their Email-ID) upon receipt of their request to the undersigned through email. The authority shall not be responsible in the event of internet connectivity problem/server problem etc (if any). The EOI proposal must be submitted to the address mentioned below on or before dt. 15.12.2010 time 1500 hrs. The EOI proposals received would be evaluated and request for proposal (RFP) will be issued to the short listed qualified firms/producers for submitting their detailed technical proposals and financial quotations. World Bank's quality and cost based selection (QCBS) method will be adopted for selection of the production firms/producers. Interested firms/producers may obtain further information from the office of the undersigned during 1100 hrs to 1700 hrs in working days. Submission of EOI proposal through Email/fax/telegraph shall not be accepted and for any postal delay the undersigned shall not be held responsible.
