ORDER

CONDITION OF APPOINTMENT

This appointment is purely temporary until further orders and may be terminated by the Engineer-in-Chief, Water Resources without assigning any reason on giving one month notice in advance of one month pay in lieu thereof.

2. If he/she wants to resign the appointment he/she must give one month notice in advance to that effect to the officer who is competent to accept the same in lieu thereof he/she will forfeit one month's pay which must be deposited in advance before the resignation is accepted.

3. He/she must at the time of joining the appointment fill-up the enclosed forms Annexure-II and submit the joining report to concerned authority as well as to Engineer-in-Chief, Water Resources.

4. He/She must at the time of joining take one oath in the following form before the Superintending Engineer or any other authority as the said Superintending Engineer directs.

(Solemnly affirm)

That I will be faithfully and bear true allegiance to Indian and to the constitution of India as by Law Establishment and I will carry out the duties of my office Royally, honestly and with impartiality" (So help me God) (Conscientious objections to oath taking may take a solemn affirmation in the prescribed form indicated as above).

5. He is directed to indicate whether he has more than one wife living. In the event of his declaration in the negative being found to be incorrect after his appointment he will be liable to be dismissed from Service.

6. He/She is hereby given an opportunity to supply an information which may be of value of determining his/her seniority in the appointment increment, etc. on account of PAR Service or the like.

7. He/She must declare his assets as on the date of a pointment in a sealed cover within three months from the date as laid down in Home; Deptt. Resolution No.12723A dated. * the 20th Aug.1963 subsequently amended in Resolution No.16992 A dated the 10th Nov.,1953, No.20605 dated. 31st Dec.,1954.
8. No travelling allowance will be paid for joining the appointment.
9. The -appointment is subject to production of character certificates from two Gazetted Officers of the Central or State Govt. only certificate attested by District Magistrate, Sub-Divisional Magistrate or other superior Officer will be accepted. . . .
10. The appointment is subject to medical fitness for which a. Certificate from recognised medical authority must be produced. . . .
